Ohio Schools Eligible for Nearly \$11 Million in Safety Grants

Ohio schools can now apply for a portion of nearly \$11 million in safety grants available for the current academic year, Attorney General Dave Yost announced.

The funding, approved through House Bill 33 by the 135th General Assembly, supports a wide range of initiatives aimed at enhancing school safety. Schools can use the grants for training and education on threat detection and prevention, as well as for life-saving tools, technology, and crisis-response equipment.

The grant funding provides school leaders with flexibility in determining the best ways to enhance student safety. Eligible uses include:

- Certification training for school resource officers
- Educational resources for all grade levels
- Active-shooter response training or equipment
- Silent panic alarms
- Alert systems for wanted dangerous individuals
- Gunshot-detection technology
- School supplies or equipment related to safety or school-safety plans
- Training to identify and assist students with mental health issues
- Systems enabling immediate camera access for responding law enforcement officers.
- License-plate reader alerts for vehicles registered to sex offenders

School leaders may apply for both a traditional per-pupil-funded grant and a larger project-based grant. Until funds are exhausted, every district is eligible to seek:

- A formula-based grant of \$2,500 or \$4.50 per student, whichever amount is greater.
- A project-based grant of up to \$40,000 per district, regardless of the number of students.

Grants will be awarded on a first-come, first-served basis, making timely application submission crucial.

The deadline for applications is May 30, 2025.

# Featured Presenter August 8, 2025 Dr. Daryl Michel Coaching for Change

Daryl Michel, PhD, consults with organizations nationally and internationally in areas such as instructional coaching, teacher education, disciplinary literacy, learning and lesson study, and curriculum design. He is the founder of Be A Change, LLC, and coauthor of Student-Focused Coaching: The Instructional Coach's Guide to Supporting Student Success Through Teacher Collaboration (Brookes Publishing, 2022). In addition to his educational consulting, he serves as a project manager for The University of Texas at Austin's Meadows Center for Preventing Educational Risk and as a statewide coordinator supporting Reading Apprenticeship for WestEd. Daryl began his career in the education profession nearly three decades ago and, today, continues to follow his passion of learning with and from others and advocating for voices and perspectives to be heard.

During Dr. Michel's Keynote, participants will explore key principles from *Student-Focused Coaching*, emphasizing relationship-building and collaboration with all stakeholder groups to understand existing systemic practices. Participants will also investigate a Collaborative Problem-Solving Process that leverages student data to define challenges, set goals, and implement targeted action steps. Additionally, this session will highlight strategies for delivering differentiated, sustained professional learning to support diverse needs, modeling research-based routines that drive organizational change.

Administrators will also gain insights into designing systems that align standards, assessments, instruction, and intervention to create a cohesive and effective learning environment.

ESCLEW would like to send a special congratulations to **Constellation Schools: Stockyard Community Elementary** and **Horizon Science Academy - Springfield** for earning this distinction.

The Momentum Award recognizes districts and buildings that have shown exceptional improvement in achievement while maintaining consistent growth. To qualify, recipients must have increased their performance index by at least three points from the 2022-2023 report card to the 2023-2024 report card and earned a value-added progress rating of four or more stars. However, districts and buildings that received an overall rating of five stars are not eligible for this award.

## **Virtual Open Meetings**

House Bill 257 takes effect on April 9th, 2025, and allows community schools to conduct public meetings virtually under certain conditions.

Boards may not begin meeting virtually until after April 9th, and **they are prohibited from meeting if any of the conditions below are met:** 



The Board members are compensated for their membership on the Board, regardless of whether they receive compensation for the meeting at issue;



The meeting involves a vote to approve a major non-routine expenditure or significant hiring decision, each as defined in the policy;



The meeting involves a proposal, approval, or vote on a tax issue or tax increase;



If the greater of at least ten percent (10%) of the Board or two or more members of the Board notify the Board President that an item in the agenda must be acted upon at a meeting conducted fully in-person; or



A party to a hearing does not consent to the hearing being conducted at a Virtual Meeting.

Boards must approve a policy authorizing the use of virtual meetings before conducting any such meeting. It is also recommended that the board adopt a policy indicating that the board will not be compensated for attendance at meetings or training. Please consult your board's legal counsel before deciding to meet virtually.

## **Open Meetings and Public Records Training**

As a reminder, board members are required to complete annual Open Meetings and Public Records trainingby April 30, 2025. ESCLEW will accept training from the <u>Attorney General</u>, <u>Auditor of State</u>, and other sources (sponsors, legal counsel, etc.).

# **ENSURING COMPLIANCE WITH INSTRUCTIONAL HOUR REQUIREMENTS**

All community schools must complete a minimum of 920 instructional hours to fulfill the academic year. This winter brought significant weather challenges across Ohio, leading to school closures necessary for the safety of students, staff, and communities. Now is the time to review your instructional hours and confirm that your school remains on track to meet the required hours outlined in the approved academic calendar.

If school closures have impacted instructional hours, bringing them below the statemandated minimum, it is crucial to develop a strategy to ensure compliance. Schools can often address this by adjusting their calendars, such as converting designated staff days into instructional time, helping to avoid extending the school year into the summer months. Taking proactive steps now will ensure a seamless transition through the remainder of the academic year and keep students on track for success.

Once a plan is in place, any adjustments to the school calendar should be presented to the Governing Authority for approval. After approval, it is essential to establish a clear communication plan to inform students, staff, and the community of any changes. Proactive communication will help minimize disruptions and ensure that adjustments to the instructional schedule do not negatively impact attendance rates.

If your school plans to adjust its calendar to add or make up instructional hours, please inform your ESCLEW Regional Technical Assistance Educator during your March site visit. This will help ensure your school remains compliant with all state regulations and instructional hour requirements. Proactive communication and planning are key to a smooth transition and successful completion of the academic year.

# **SPRING INTO STATE ASSESSMENTS**

As the calendar turns to March, the academic focus of many classrooms tends to turn to "test prep" mode to prepare for the state assessments. In many cases, this focus is on the students and what they need to know, how they need to show they know it, and the incentives given for students to take the state test seriously. But what about your staff? Are they prepared to administer the high-stakes Ohio's State Tests to students? Many of our schools may have substitute teachers filling classroom teacher roles who may never have been through a rigorous "testing" season. They may need support in the same fashion as students, preparation of what to expect, and how to follow all school policies and procedures to ensure the safety and security of the testing environment and keep data secure. Although the substitute teacher may be doing a phenomenal job in the classroom, it is important to support them just as much as students throughout the whole spring testing process. After all, the entire school shares the results and takes pride in the student's and staff's annual achievements.

The **English Language Arts Testing** window opens on Monday, March 24, 2025, and closes on Friday, April 25, 2025 **Math, Science, and Social Studies Testing** window opens on Monday, March 31, 2025, and closes on Friday, May 9, 2025.

It is important to note that all testing must be given within **15 consecutive days** of the assigned window. This timeline includes all make-up tests given to students who were absent. Make sure the calendar adheres to this timeline.

In many cases, the end-of year-assessments either overlap with the state testing or closely follow each other as the school year comes to an end. School administrators will want to ensure the logistics of scheduling assessments to remain within the given time frames and avoid student and staff burnout. Both forms of assessment are high stakes for the school and both should be carefully planned to ensure students are performing to their best academic ability. While the Ohio State Test determines the outcome of the school's report card, the end-of year-assessments determine the outcome of the school's academic goals on the Performance Framework (Contract Attachment 11.6) which plays a role in the contract renewal process.

# **Compliance Headlines**

### **ITEMS OF NOTE - MARCH 2025**

- #667 Open Meetings & Public Records Training Affidavit is due April 30th. Board members, treasurer, chief administrative officer, other administrative employees, and all individuals performing supervisory or administrative services for the school under a contract with the operator of the school are required to complete annual training on public records and open meetings law.
- The **Five-Year Forecast Update** is due in Epicenter by **April 30th**. Although approved meeting minutes/resolution are not collected by ESCLEW/ODEW, the forecast must be board approved prior to submission. If your school has a board meeting scheduled in May, please reach out to Julie Kadri to discuss an extension.

#### **School Submissions**

• #819 Community School Transportation Plans – If a community school is working with or intends to work with a local district to provide transportation, the school must notify the local district by April 1st. Please submit into Epicenter a copy of establishment of the school's start and end times and proof of providing that information to applicable school districts (copy of the email, etc.) by April 1st. If the community school does not expect one or more resident school districts to transport the school's students, please enter N/A in the narrative.
