# BACK TO SCHOOL - ON-SITE VISITS - HOW IS YOUR SPONSOR HELPING YOUR SCHOOL THIS YEAR?

School is back in session, and that means our ESCLEW Regional Technical Assistance Educators (RTAEs) are back to visiting schools. As a result of ESCLEW's process of examining practices, gathering feedback, and making changes to become more efficient and effective, ESCLEW is taking a new approach to on-site visits this year. In an effort to take less of the building leader's time, and make the time they do spend more meaningful, RTAEs will be conducting six (6) compliance visits where the building leader's attendance is not required. The remaining five (5) visits will be academic on-site visits which will involve a closer look at student data and individualized technical assistance. Board members are encouraged to attend site visits with RTAEs when available in order to gain a deeper understanding of the role of the sponsor and to satisfy their Attachment 11.6 board engagement goal.

The ESCLEW Annual Statewide Meeting is Wednesday, September 18th in Toledo. As board members, you are valued participants on this day. The morning session will include remarks from Colleen Grady from ODEW, Adam Schira from Dickinson Wright, and an eye-opening, impactful session from Elizabeth Kregel on how trauma re-wires the brain and how and why students experience amygdala hijacks.

An amygdala hijack occurs when the amygdala overrides a person's ability to respond rationally to a perceived threat. When this occurs, we often see students extremely escalated and exhibiting violent behavior. In the session, Elizabeth will also discuss how educators can safely and effectively manage "hijacked" students and get to the root cause of the behavior.

# ATTENDANCE AWARENESS MONTH — STAY IN THE GAME!

September is Attendance Awareness Month, a nationwide recognition of the connection between regular school attendance and academic achievement. Celebrate with the <u>Stay in the Game!</u> Attendance Network by participating in planned events each week to encourage attending school every day and reducing chronic absenteeism. Some schools may even be recognized by the Cleveland Browns, Columbus Crew, FC Cincinnati, or the Ohio Department of Education and Workforce. Schools can check out the <u>spirit week flyer</u> and participate in engaging activities to generate excitement and encourage regular attendance.

A student who misses just two to three days of school per month can be chronically absent. Attendance Awareness Month highlights the importance of mobilizing schools, families, and community partners to promote and implement tiered strategies and personalized interventions to reduce chronic absenteeism. When students are not chronically absent, they are far more likely to read at grade level, succeed academically, graduate on time, and be ready for the workforce.

Ohio's chronic absenteeism rate for the 2022-2023 school year was 26.8%, which has improved statewide by 3.4% from the 2021-2022 school year.

#### **ITEMS OF NOTE - SEPTEMBER 2024**

As a reminder, ESCLEW issued guidance regarding Auditor of State (AOS) Fraud Prevention Training required for every public employee by November 29, 2024. <u>Click here to access the eight (8) minute training, optional tracking logs, and FAQ</u>. Schools must track training, collect employee certificates, and keep documentation on-site for their annual fiscal audit. We are asking schools to certify in Epicenter that training is complete by November 15th.

Based on the mandates of the Individuals with Disabilities Education Act (IDEA), assistive technology devices and services must be considered for all students with disabilities in the development of the Individualized Education Program (IEP). This module will assist educational professionals and IEP team members in considering and determining student needs for assistive technology. More specifically, this module will describe the difference between AT consideration and AT assessment. Additionally, the module details how the IEP team documents AT consideration on the Special Instructional Factors page of the IEP.

# COMPLIANCE TIP Planning Form/ETR Part 1 Assessment Guidance

Did you know that whoever is listed on the ETR Planning Form for assessments that require "additional testing" must complete their own Part 1? If the Planning Form states "sufficient data", the school psychologist may gather the data from the other staff member and include it in their Part 1. In this case, the contributing staff member must be referenced in the Part 1, and both the school psychologist and the staff member must sign the document. If more than one person is listed as conducting an assessment, both individuals must complete a Part 1.

# **Whoever is Listed Must Complete the Part 1**

The justification is the parent signs the ETR Planning Form and the Consent Form.

By signing the form they are giving permission for the person listed on the ETR

Planning Form to provide the assessment. If someone other than who is listed on the planning conducts the assessment, it would then not be informed consent.

## PROFILE SUBMISSION DEADLINE

If your school had to complete an improvement plan from the 2023-2024 Special Education Profiles, the evidence of those plan activities is due September 29, 2024. Please inform your ESCLEW Special Education Specialist when they are submitted and if they are approved by ODEW.
